R&DA would like to thank you for your participation as a vendor at our 2024 Spring Meeting that will be held at The Westin La Paloma. The vendor exhibition will take place May 6-8, 2024, in the Conference Center located on the lobby level of the hotel in the Canyon-Grand Foyer area.

Your display area will include one six-foot table, and two side chairs. If you are shipping material for the exhibits, please note that the hotel will accept shipments only <u>after</u> May 1<sup>st</sup> and <u>not later</u> than *May 3rd*.
